BE it enacted:

Short title.

1. This Law may be cited as the Village Authorities (Amendment) Law, 1928, and shall be read as one with the Village Authorities Law, 1923, (hereinafter referred to as the Principal Law), and the Principal Law and this Law may together be cited as the Village Authorities Laws, 1923 and 1928.

WHEREAS it is necessary to make provision for such Preamble. expenses of the Government of Cyprus for the year ending the thirty-first day of December, 1929, as are not already lawfully provided for or shall not hereafter be provided for by any Law.

BE it therefore enacted :-

- 1. This Law may be cited as the Appropriation Law, 1929. Short title.

In addition to the sums already lawfully appropriated Appropriato the service of the King or which may be hereafter law- tion of fully appropriated thereto, there shall be issued and applied to the service of the twelve months ending the thirty-first day of December, 1929, out of the revenue and other funds of the Colony, any sum not exceeding the sum of Six Hundred Thousand Two Hundred and Fifty-four Pounds for defraying the charge of the Government of Cyprus for such period.
