Short title,

1. This Law may be cited as the Police (Amendment) Law, 1929, and shall be read as one with the Police Law, 1878, (hereinafter referred to as the Principal Law), and the Police (Amendment) Law, 1927, and the Police (Amendment) Law, 1928, and the Principal Law and the said Laws and this Law may together be cited as the Police Laws, 1878 to 1929.

"78. Any sum paid in respect of damages to the 78, and sub-Police Group Commander under the provisions of this stitution of new section. Law shall forthwith be paid by him as follows :--

Eighty-five per centum thereof shall be paid to the person entitled to the same under the provisions of this Law.

Fifteen per centum thereof shall be paid into the Revenues of Cyprus in such manner as the Chief Commandant of Police shall direct. Provided that in attributing the share payable into the Revenues no fraction of a piastre shall be payable thereto."

PART I.

TITLE AND INTERPRETATION.

1. This Law may be cited as the Criminal Evidence Short title. and Procedure Law, 1929.
