BE it enacted:—

Short title.

1. This Law may be cited as the Kythraea Water Supply Improvement (Amendment) Law, 1932, and shall be read as one with the Kythraea Water Supply Improvement Law, 1928, (hereinafter called “the Principal Law”), and the Principal Law and this Law may together be cited as the Kythraea Water Supply Improvement Laws, 1928 and 1932.

2. Section 15 (1) (b) of the Principal Law is hereby amended by the deletion therefrom of the words “meter and tap” and the substitution therefor of the words “tap or meter”.

A LAW FURTHER TO AMEND THE LOAN LAW, 1930.

BE it enacted:—

Short title.

1. This Law may be cited as the Loan (Amendment) Law, 1932, and shall be read as one with the Loan Law, 1930, (hereinafter called “the Principal Law”), and the Principal Law and this Law may together be cited as the Loan Laws, 1930 to 1932.

2. The long title to the Principal Law is hereby repealed and the following long title substituted therefor:

“A LAW TO MAKE PROVISION FOR RAISING A LOAN OF FIVE HUNDRED AND SEVENTY-FOUR THOUSAND POUNDS STERLING FOR THE CONSTRUCTION OF CERTAIN PUBLIC WORKS AND FOR THE REPAYMENT OF CERTAIN LOANS.”

3. The preamble to the Principal Law is hereby amended by the deletion of the words “Six Hundred Thousand” and the substitution therefor of the words “Five Hundred and Seventy-Four Thousand”.

4. Section 3 of the Principal Law is hereby amended by the deletion of the words "six hundred thousand" and the substitution therefor of the words "five hundred and seventy-four thousand".

Amendment of section 3 of the Principal Law.

5. Section 4 of the Principal Law is hereby repealed and the following section substituted therefor:—

Repeal of section 4 of the Principal Law and substitution of new section.

"Application of loan.

4. The money to be borrowed under the authority of this Law shall be appropriated and applied to the purposes specified in the First and Second Schedules hereto:

Provided that it shall be lawful for the Governor with the sanction of the Secretary of State to utilize any savings in respect of any item in the First Schedule hereto to cover any excess of expenditure in respect of any other item in the said Schedule."

6. Section 5 of the Principal Law is hereby amended by the deletion of the words "three years" and the substitution therefor of the words "two years".

Amendment of section 5 of the Principal Law.

7. The Schedule to the Principal Law is hereby repealed and the following First Schedule substituted therefor:—

Repeal of schedule to the Principal Law and substitution of new schedule.

Insertion of second schedule in the Principal Law.

" SECOND SCHEDULE.

Repayment in a lump sum of the balance of funds borrowed from the Imperial Treasury under the provisions of the Security for Advances and Public Works Law, 1900, for the purposes of constructing Irrigation Works and a Harbour and Railway £152,504"

9. The Loan (Amendment) Law, 1932, (No. 25 of 1932), is hereby repealed.
