BE it enacted :—

This Law may be cited as the Companies (Limited Liability) Amendment Law, 1934, and shall be read as one with the Companies (Limited Liability) Laws, 1922 and 1931, (hereinafter called "the Principal Law"), and the Principal Law and this Law may together be cited as the Companies (Limited Liability) Laws, 1922 to 1934.

2. The First Schedule to the Principal Law is hereby repealed and the following substituted therefor :—

BE it enacted :—

1. This Law may be cited as the Firearms (Amendment) Law, 1934, and shall be read as one with the Firearms Law, 1933, (hereinafter called "the Principal Law"), and the Principal Law and this Law may together be cited as the Firearms Laws, 1933 to 1934. Short title.

2. The definition of "Local ^(N^o 2) Commandant" in section 2 of the Principal Law is hereby amended by the insertion immediately after the word "Police" of the words "or officer for the time being in charge of the Police". Amendment of section 2 of Law 31 of 1933.

3. Section 3 of the Principal Law is hereby amended as follows :— Amendment of section 3 of Law 31 of 1933.

- (a) by the insertion in sub-section (2) immediately after the word "importation" of the words "or possession";
- (b) by the insertion in the proviso to sub-section (2) immediately after the word "import" of the words "or possess";
- (c) by the insertion * [in sub-section 3] immediately after the words "to import" (in line 3) of the words "or who has in his possession".
