A LAW TO AMEND THE OATHS AND AFFIDAVITS LAWS, 1931 AND 1933.

BE it enacted:—

1. This Law may be cited as the Oaths and Affidavits (Amendment) Law, 1936, and shall be read as one with the Oaths and Affidavits Laws, 1931 and 1933, (hereinafter called "the Principal Law"), and the Principal Law and this Law may together be cited as the Oaths and Affidavits Laws, 1931 to 1936.

2. Section 2 of the Principal Law is hereby amended by the addition thereto of the following sub-section:—

"(3) Where any oath or affidavit is required to be taken or made under the British Nationality and Status of Aliens Act, 1914, or any Act amending or substituted for the same or any regulations made thereunder, such oath or affidavit shall be taken or made before the Commissioner of the District in which the deponent resides."

This Law came into operation on 20th November, 1936.

A LAW TO PROVIDE FOR THE IMPOSITION OF ADDITIONAL IMPORT DUTIES ON CERTAIN GOODS.

BE it enacted:—

1. This Law may be cited as the Customs (Additional Import Duties) Law, 1936, and shall be read as one with the Customs Law, 1936.

2. Notwithstanding anything contained in the Customs Law, 1936,—

(1) there shall be levied and collected upon any of the articles mentioned in the Schedule hereto, not being goods charged at the preferential rate set forth in the

fourth column of the First Schedule to the Customs Law, 1936, but which fall within any description of goods mentioned in the second column of that Schedule and which shall be imported into the Colony or taken out of bond for home consumption, an additional import duty equal to double the import duty set forth in the general tariff rate of duty opposite to such description of goods in the fifth column of the said First Schedule to the Customs Law, 1936 ;

(2) there shall be levied and collected upon any of the articles mentioned in the Schedule hereto, not being goods of British Empire origin, manufacture or production, but which fall within any description of goods mentioned in the Table of Exemptions contained in the Second Schedule to the Customs Law, 1936, and which shall be imported into the Colony or taken out of bond for home consumption, an import duty equal to double the import duty set forth in the general tariff rate of duty opposite to item No. 115 or No. 116, as the case may be, in the fifth column of the First Schedule to the Customs Law, 1936.

3. This Law shall continue in force until the 1st day of June, 1937, and no longer. Duration
of Law.

SCHEDULE.

1. Articles of all kinds suitable for use for or in connection with the celebration or commemoration of the Coronation of His Majesty or as the souvenirs thereof, being articles which consist of, or bear, a representation of His Majesty, any member of the Royal Family, the Royal cipher, the Royal arms, any Royal emblem, escutcheon, badge, crest, armorial bearings or insignia, any article or building associated with the Coronation, or a flag of any country in the British Empire, or which consist of or bear any other mark or device which renders them suitable for use as aforesaid.

2. Flags of any country in the British Empire and flags resembling any such flag.

This Law came into operation on 11th December, 1936.
