(2) Upon the publication of any such order as aforesaid, and for so long as the order shall remain in force, the term 'flock' in this Law shall be read and construed accordingly."

A LAW TO APPROPRIATE A SUM NOT EXCEEDING SIX THOUSAND NINETY-FOUR HUNDRED AND HUNDRED AND NINETY-SEVEN POUNDS TO THE SERVICE OF THE TWELVE MONTHS ENDING THE THIRTY-FIRST DAY OF DECEMBER, IN THE YEAR OF OUR LORD ONE THOUSAND NINE HUNDRED AND THIRTY-SEVEN.

THEREAS it is necessary to make provision for such Preamble. expenses of the Government of Cyprus for the year ending the thirty-first day of December, 1937, as are not already lawfully provided for or shall not hereafter be provided for by any Law.

BE it therefore enacted:

1. This Law may be cited as the Appropriation Law, 1937. short title.

- 2. In addition to the sums already lawfully appropriated Appropriato the service of the King or which may be hereafter £694,297. lawfully appropriated thereto, there shall be issued and applied to the service of the twelve months ending the thirty-first day of December, 1937, out of the revenue and other funds of the Colony, any sum not exceeding the sum of Six Hundred and Ninety-Four Thousand Two Hundred and Ninety-Seven Pounds for defraying the charge of the Government of Cyprus for such period.
- 3. A sum not exceeding the amount set down under Limitation each head in the Schedule hereto may be issued and spent of the sum in respect of the Establishment or Service specified and to be spent on Personal referred to therein; provided that the total sum spent on Personal Emoluments during the year, appropriated under this Law, shall not exceed the sum of Two Hundred and Sixty-Three Thousand One Hundred and Twenty-One Pounds.
