THE STATUTE LAWS OF CYPRUS No. 2 of 1939.

A LAW TO AMEND THE VILLAGE OBLIGATIONS LAWS, 1901 TO 1937.

H. R. PALMER,] [10th March, 1939. Governor.

BE it enacted by His Excellency the Governor and Commander-in-Chief of the Colony of Cyprus as follows:—

1. This Law may be cited as the Village Obligations Short title. (Amendment) Law, 1939, and shall be read as one with the

Village Obligations Laws, 1901 to 1937, (hereinafter called ^{7 of 1901} ^{34 of 1928} "the Principal Law"), and the Principal Law and this ^{15 of 1937} Law may together be cited as the Village Obligations Laws, 1901 to 1939.

2. Section 11 of the Principal Law is hereby amended as Amendment of section

(a) By the deletion of sub-section (1) thereof, as a mended by section 2 (a) of the Village Obligations
(Amendment) Law, 1937, and by the substitution 1 therefor of the following sub-section :—

"(1) In every case in which any contract or obligation imposing any pecuniary liability upon a Village Community has been entered upon in manner hereinbefore in this Law provided, it shall be the duty of the Mukhtar in conjunction with the other members of the Village Commission of such Village Community to prepare, within twenty-eight days from the date of the execution of such contract or obligation, a list showing the amount of money which should equitably be contributed by each householder and proprietor for the purpose of meeting such pecuniary liability and providing

for the payment of a fee to the Mukhtar at the rate of ten shillings in respect of the first year and at the rate of five shillings in respect of each subsequent year during which such pecuniary liability will continue under such contract or obligation. In the case of a proprietor the assessment shall be based upon the extent of the benefit accruing to the property of each proprietor under such contract or obligation."

(b) By the insertion in sub-section (9) thereof of the words "with the assistance of the Mukhtar" immediately after the words "shall be revised by the Commissioner."

) E it enacted by His Excellency the Governor and Commander-in-Chief of the Colony of Cyprus as follows :-

1. This Law may be cited as the Agricultural Bank of Cyprus Limited (Special Privileges) Law, 1939.

2. In this Law-

"Agricultural Bank" means the Agricultural Bank of Cyprus Limited, a company incorporated under the Companies (Limited Liability) Laws, 1922 to 1938, whose registered office is situated at Nicosia in the Colony;

"Co-operative Society" means a society formed under the provisions of—

(a) the Co-operative Credit Societies Laws, 1914 to 1937. or
