DE it enacted by His Excellency the Officer Administering the Government and Commander-in-Chief of the Colony of Cyprus as follows :-

Short title.

1. This Law may be cited as the Village Authorities (Fees Regulation) Law, 1943.

BE it enacted by His Excellency the Officer Administering the Government and Commander-in-Chief of the Colony of Cyprus as follows :-

1. This Law may be cited as the Agricultural Debtors short title.
