THE STATUTE LAWS OF CYPRUS

No. 19 of 1947.

**A LAW TO AMEND THE GAME AND WILD BIRDS LAWS,
1934 TO 1941.**

BE it enacted by His Excellency the Governor and
Commander-in-Chief of the Colony of Cyprus as
follows :—

1. This Law may be cited as the Game and Wild Birds
(Amendment) Law, 1947, and shall be read as one with
the Game and Wild Birds Laws, 1934 to 1941, (hereinafter
referred to as "the principal Law"), and the principal
Law and this Law may together be cited as the Game and
Wild Birds Laws, 1934 to 1947.

2. Section 2 of the principal Law is hereby amended by the deletion therefrom of the definition "Close Season" and the substitution therefor of the following definition:—

" 'Close Season' means the period between the 1st February and the 30th September, both days inclusive, in every year."

3. Section 6 of the principal Law is hereby repealed and the following section substituted therefor:—

" Power
to the
Governor
to prohibit
shooting,
etc., of
game and
wild bird.

6.—(1) The Governor, by order to be published in the *Gazette*, may—

(a) in addition to the Close Season as in this Law provided, prohibit, in every five years, the shooting, killing, taking, pursuing or selling of any game or wild bird during any period as may be specified in such order and any such period shall be deemed to be a Close Season for all purposes of this Law;

(b) prohibit, at any time, the shooting, killing, taking, pursuing or selling of any particular type of game for such time as may be specified in the order.

(2) Any person who acts in contravention of any order made under sub-section (1) of this section shall be guilty of an offence and shall be liable to imprisonment not exceeding six months or to a fine not exceeding fifty pounds or to both."

4. Section 10 of the principal Law is hereby repealed and the following section substituted therefor:—

" Certain
practices in
shooting,
etc., game
prohibited.

10. No person shall, in shooting, killing, taking or pursuing any game—

(a) make use of a decoy or shelter;

(b) make use of a motor car or motor cycle at night time for the purpose of shooting game therefrom or for the purpose of attracting and shooting game;
