A LAW TO AMEND THE ESTATE DUTY LAWS, 1942 TO 1946.

DE it enacted by His Excellency the Governor and Commander-in-Chief of the Colony of Cyprus as follows :---

1. This Law may be cited as the Estate Duty (Amend- short title. ment) Law, 1948, and shall be read as one with the Estate Duty Laws, 1942 to 1946, (hereinafter referred 28 of 1942 to as "the principal Law"), and the principal Law and 16 of 1944 this Law may together be cited as the Estate Duty Laws. 1942 to 1948.

2. Section 4 of the principal Law is hereby amended Amendment by the deletion in the proviso thereto of the words "five of section 4 hundred pounds" (lines 2 and 3) and the substitution principal therefor of the words "two thousand pounds".

Amendment of section 6 (1) of the principal Law.

Repeal of the Schedule to the principal Law and substitution of new Schedule.

Date of commencement. 3. Sub-section (1) of Section 6 of the principal Law is hereby amended by the deletion in the second proviso thereto of the words "five hundred pounds" (last line) and the substitution therefor of the words "two thousand pounds".

4. The Schedule to the principal Law is hereby repealed and the Schedule to this Law substituted therefor.

5. This Law shall be deemed to have come into operation on the 1st day of January, 1948.
