THE STATUTE LAWS OF CYPRUS

No. 13 OF 1951.

**A LAW TO PROVIDE FOR THE EXTENSION OF THE DURATION
OF THE MUNICIPAL COUNCIL OF ATHIENOÛ.**

WHEREAS by Proclamation made under section 3 (2) of the Municipal Corporations Laws, 1930 to 1945, published in Supplement No. 3 to the *Gazette* of the 18th March, 1948, the village of Athienou in the District of Larnaca was proclaimed a municipal corporation ;

And whereas, after due elections by poll, a council of the said municipal corporation was elected to hold office for a period of three years as from the 1st June, 1948 ;

And whereas in the meantime by the Municipal Corporations (Amendment) Law, 1948, the duration of municipal councils has been extended and provision made for a four-yearly preparation of electors' lists, for general elections of councils, commencing in 1949 ;

And whereas it is desirable to have uniformity with regard to the date of the expiration of all municipal councils and the date for the four-yearly preparation of electors' lists for the general elections of councils under the said Laws :

BE it therefore enacted by His Excellency the Governor and Commander-in-Chief of the Colony of Cyprus as follows :—

Short title.

1. This Law may be cited as the Municipal Corporations (Athienou Council Extension) Law, 1951.

Extension of the duration of the council.

2. Notwithstanding anything contained in the Municipal Corporations Laws, 1930 to 1950, or any public instrument, the duration of the council of the municipal corporation of Athienou which is due to expire on the 31st May, 1951, shall be extended to the 31st May, 1953, and the election for a new council in respect thereof shall not be held until the year 1953.

3. The provisions of the Municipal Corporations Laws, 1930 to 1950, shall apply to the municipal corporation of Athienou and to the council thereof, the duration whereof is extended as in section 2 provided, and, for the purposes of the preparation and revision of electors' lists and electors' rolls, the first electors' lists and electors' rolls in respect of the municipal corporation of Athienou shall be deemed to have been made in the year 1949, in accordance with the provisions of the said Laws.

Date of commencement.

4. This Law shall be deemed to have come into operation on the 1st day of January, 1951.
