A LAW TO AMEND THE VILLAGE AUTHORITIES LAWS, 1931
TO (No. 2) 1937.

BE it enacted by His Excellency the Governor and
Commander-in-Chief of the Colony of Cyprus as
follows :—

1. This Law may be cited as the Village Authorities
(Amendment) Law, 1951, and shall be read as one with the
Village Authorities Laws, 1931 to (No. 2) 1937 (hereinafter
referred to as "the principal Law"), and the principal Law
and this Law may together be cited as the Village Authorities
Laws, 1931 to 1951.

2. The principal Law is hereby amended by the insertion therein, immediately after section 8, of the following section :—

“ Acting
mukhtar.

8A. In the case of a temporary illness, absence or other temporary incapacity of a mukhtar, the Commissioner may appoint any other person to act as mukhtar during the continuance of the temporary illness, absence or other temporary incapacity of the mukhtar and every such person so appointed shall, while so acting, exercise all the powers and perform all the duties of a mukhtar.”

3. The principal Law is hereby amended by the insertion therein, immediately after section 10, of the following section :—

“ Power to
Governor in
Council to
enable

Commissions
to hold

etc.

10A.—(1) The Governor in Council may, by Order published in the *Gazette*, direct that, with regard to such village as may be specified in the Order, the village Commission thereof shall have power within the village—

- (a) to hold and administer such property as may be described in the Order ;
- (b) to establish and maintain village markets, slaughter-houses and such other premises as may be described in the Order and charge in connection therewith such fees as the village Commission may prescribe with the approval of the Commissioner ;
- (c) to exercise such other powers as may be specified in the Order,

and, thereupon, the village Commission shall have and exercise the powers set out in the Order in accordance with the tenor thereof.

(2) Any Order made under this section may contain such incidental, consequential or supplementary provisions for the regulation, use, control, restriction or prohibition of anything in connection with, or arising out of, any matter referred to in sub-section (1), as the Governor in Council may think necessary or expedient for the effective carrying out of the Order, including the establishment of a fund into which money received by the village Commission under this section shall be paid and out of which payments shall be made for such purposes as may be specified in the Order.
